A victim or the family of a victim of a crime committed in New Jersey can be repaid for losses and expenses that resulted from the crime. This repayment is called restitution. All convicted persons (offenders), might have to pay restitution to the victim or the victim's family.

Restitution fines are a major source of funding for the State's Restitution Fund. The California Victim Compensation Board (CalVCB) uses the Restitution Fund to assist victims and their families with economic losses suffered as a direct result of a qualifying crime. The restitution fine shall be proportionate with the seriousness of the offense.

Adult offenders are required to pay \$150 to \$1,000 for a misdemeanor and \$300 to \$10,000 for a felony. Restitution fines go into the State's Restitution Fund,
